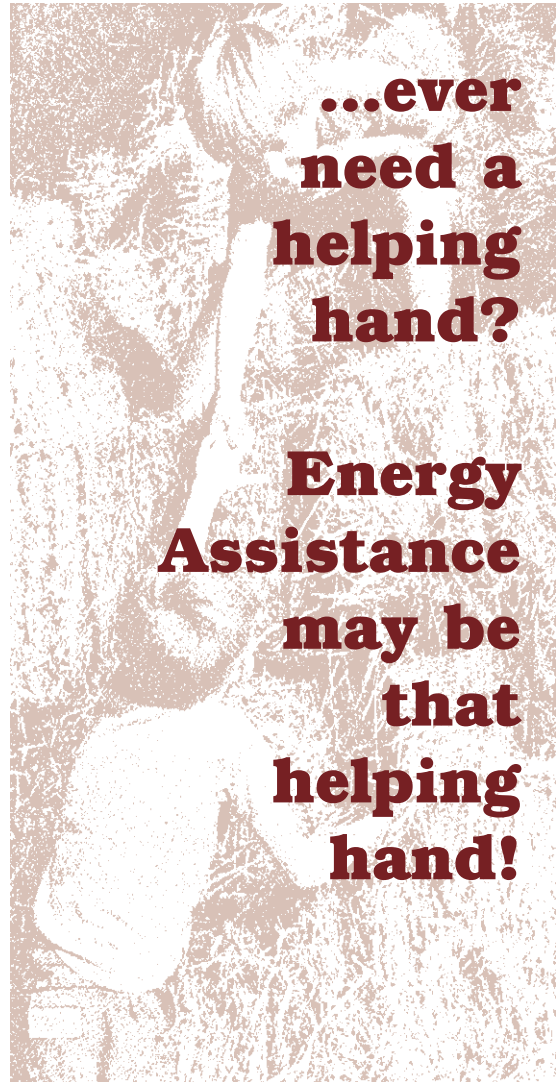

# WHAT IS ENERGY ASSISTANCE?

LIHEAP (Low Income Home Energy Assistance Program) is a federally funded program for qualified households which provides a one-time benefit (per program year) to assist with heating costs.

## Essential Energy Assistance Facts:

1. Applications are taken from November 1<sup>st</sup> to March 31<sup>st</sup>.
2. Applications may only be submitted to Community Action Agencies.
3. The financial eligibility requirement is 160% of Federal poverty guidelines, see chart below.
4. There is a one-time benefit per year.
5. Participants must re-apply each year.
6. Other assistance programs could have an impact on the issuance of LIHEAP benefits.

### **\*IMPORTANT\***

You must contact your local Community Action Agency to receive an application for energy assistance.
