

**Create Your Comfort Zone Sweepstakes**

**SWEEPSTAKES OFFICIAL RULES**

This sweepstakes is sponsored by Intermountain Gas Company ("IGC" or "Sponsor") and is governed by these official rules ("Official Rules"). By participating in the contest, each entrant agrees to abide by these Official Rules, including all eligibility requirements, and understands that the results of the contest, as determined by IGC are final in all respects. The contest is subject to all federal, state, and local laws and regulations and is void where prohibited by law.

**1. NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.**

- 2. HOW TO ENTER:** Beginning on October 1<sup>st</sup> at 12:00 AM MST through November 7th, 2025, at 11:59 PM MST ("Sweepstakes Period"), visit the Energy Savings Tips page, located at [www.intgas.com/energy-efficiency\\_program/energy-saving-tips/](http://www.intgas.com/energy-efficiency_program/energy-saving-tips/), provide your first name, last name, street address and answer to the question "What's your favorite way to stay warm during winter?" in the sweepstakes entry area where indicated. Online Entries must be received by no later than 11:59 p.m. MST on the last day of the Sweepstakes Period, or the entry is not eligible for the Create Your Comfort Zone Sweepstakes drawing. No submissions will be accepted after the Sweepstakes Period for any reason regardless of the method of entry. You may enter only once per household. Use of any robotic, automatic, programmed, or similar entry method or entering more than the number of times permitted will void all entries and result in disqualification. You may not enter more times than indicated by using multiple email addresses, identities, or devices in an attempt to circumvent the rules.
