

**Watch and Win Sweepstakes**  
**INTERMOUNTAIN GAS COMPANY**  
**SWEEPSTAKES OFFICIAL RULES**

This sweepstakes is sponsored by Intermountain Gas Company (“IGC” or “Sponsor”) and is governed by these official rules (“Official Rules”). By participating in the contest, each entrant agrees to abide by these Official Rules, including all eligibility requirements, and understands that the results of the contest, as determined by IGC are final in all respects. The contest is subject to all federal, state, and local laws and regulations and is void where prohibited by law.

**1. NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.**

**2. HOW TO ENTER:** Beginning on September 2<sup>nd</sup>, 2024 at 12:00 AM MST through October 4<sup>th</sup>, 2024, at 11:59 PM MST (“Sweepstakes Period”), visit the Energy Savings Tips page, located at [www.intgas.com/energy-efficiency\\_program/energy-saving-tips/](http://www.intgas.com/energy-efficiency_program/energy-saving-tips/). to this page, watch each home weatherization video and select the video you found most beneficial, then, provide your name and street address in the sweepstakes entry area where indicated. Online Entries must be received by no later than 11:59 p.m. MST on the last day of the Sweepstakes Period, or the entry is not eligible for the Watch and Win Sweepstakes drawing. Alternatively, you may also enter the Watch and Win Sweepstakes drawing by legibly printing the title of your selected video along with your name, service address, city, state, zip code, and telephone number on a 3 X 5-inch card or piece of paper and mail it in Gas Company, Watch and Win Sweepstakes, 555 S. Cole Road, P. O. BOX 7608 Boise, ID 83709 (“Watch and Win Sweepstakes Mail Entry”). All mailed entries must be postmarked on or before the last day of the Sweepstakes Period.

No submissions will be accepted after the Sweepstakes Period for any reason regardless of the method of entry. You may enter only once per household. Use of any robotic, automatic, programmed, or similar entry method or entering more than the number of times permitted will void all entries and result in disqualification. You may not enter more times than indicated by using multiple email addresses, identities, or devices in an attempt to circumvent the rules. If you use fraudulent methods or otherwise attempt to circumvent the rules, your submission may be removed from eligibility at the sole discretion of IGC.

All entries become the sole and exclusive property of Sponsor and will not be returned. Receipt of entries may not be acknowledged, and proof of submission will not be deemed to be proof of receipt by Sponsor. Sponsor reserves the right in its sole discretion to reject any entry for failure to fully comply with these Official Rules.

**3. ELIGIBILITY:** The sweepstakes is open only to Sponsor’s residential customers in the state of Idaho who are at least eighteen (18) years of age and older at the time of entry. Employees or representatives of Sponsor and Sponsor’s parent corporation, its subsidiaries, affiliates, or agents, and their immediate family members (spouse, parent, child, sibling, and their respective spouses) and those living in the same household of each (whether legally related or not) are not eligible to enter or win the sweepstakes. All applicable federal, state and local laws and regulations apply. Only participants who

comply with all terms and conditions of these Official Rules will be eligible to win. Void where prohibited by law.

4. **DRAWING.** The winner will be selected on or about October 18<sup>th</sup>, 2024, in a random drawing from all eligible entries received or postmarked during the Sweepstakes Period and in accordance with these Official Rules. Potential winner(s) will be notified by email given one is provided, or by phone if this is the only form of contact present. The return of any prize notification or prize as undeliverable may result in disqualification and an alternate winner may be selected. All income taxes resulting from acceptance of prize are the responsibility of the winner.
  
5. **PRIZES AND APPROXIMATE RETAIL VALUE:** Total prize value: 5 separate prizes, each an individual \$100 gift card. Prize consists of only those items specifically listed as part of the prize. Limit one prize per household. No substitution or transfer of prize permitted by winner. The prize is not redeemable for cash. Sponsor reserves the right to substitute a prize of equal or greater value. If a potential winner is disqualified for any reason, Sponsor will award the applicable prize to an alternate winner by random drawing from among all remaining eligible entries. Only three (3) alternate drawings will be held, after which the prize will remain un-awarded.
  
6. **ODDS OF WINNING:** Odds of winning will be dependent on the number of eligible entries received in accordance with these Official Rules. Sponsor cannot accurately predict the number of entries to be submitted in the sweepstakes. Odds of an entry winning any prize will be the same, whether the entry was submitted by a Watch and Win Sweepstakes Online Entry or through a Watch and Win Sweepstakes Mail Entry.
